# SETTLEMENT AGREEMENT AND STIPULATED FINAL COMPLIANCE ORDER

This Settlement Agreement and Stipulated Final Compliance Order ("Final Order") is entered into between the Environmental Protection Division ("Division") of the New Mexico Environment Department (the "Department") and the Respondent, Enterprise Products Operating, LLC ("Respondent") (collectively, the "Parties") to resolve alleged statutory, regulatory, and permit violations by the Respondent. The Department alleges violations of the New Mexico Air Quality Control Act ("AQCA"), NMSA 1978, Sections 74-2-1 to -17; the Air Quality Control Regulations ("AQCR"), 20.2. NMAC ("Regulations"), and Air Quality Permit Numbers P218-R2 and 0613-M8 ("Permits").

#### I. BACKGROUND

#### A. PARTIES

1. The Department is an agency of the executive branch of the State of New Mexico, created pursuant to NMSA 1978, § 9-7A-4. The Division is an organizational unit of the Department. The Secretary of the Department has delegated to the Director of the Division the authority to seek administrative enforcement of the AQCA and the AQCR, including assessing

civil penalties for violations thereof. NMSA 1978, § 74-2-12. The Air Quality Bureau ("Bureau") is an organizational unit of the Division.

2. The Respondent is a Limited Liability Company doing business in New Mexico at the Blanco C & D Compressor Station Facility ("Facility"), located in San Juan County, New Mexico. The Facility is a natural gas compressor station.

#### B. HISTORY AND ALLEGED VIOLATIONS

- **3.** Permit P218-R2, Condition A420.A provides in relevant part, "The permittee shall not exceed the pilot/purge pph and tpy allowable emissions in Table 405.A."
- 4. On June 1, 2015, the Department received a voluntary self-disclosure letter from the Respondent. The Respondent had implemented the monitoring of flow gas to the FL-01 flare as a means to track flare events and to enhance the ability to maintain records required by Permit P218-R2, Condition A420.A. The disclosure letter stated that this monitoring data indicated that the flow of gas to Fl-01 was exceeding permitted allowable rates.
- 5. On January 13, 2016, the Respondent submitted a Significant Permit Revision Request to Permit 0613-M8 (NSR Permit) to adjust the permit emission limits for flare FL-01 to match actual operating conditions. The issuance of the permit revision on May 9, 2016 ended the permit exceedances.
- **6.** On March 2, 2016, the Bureau issued to the Respondent Notice of Violation ENT-3552-1501-SD ("NOV"), alleging violations of the AQCA, the AQCR, and the Permit. The alleged violation consists of the failure to limit flow to the flare Unit FL-01 to below permit levels, which is a violation of Permit P218-R2 Condition A420.A.

- 7. The NOV included a Corrective Action Verification ("CAV") requiring the Respondent to submit to the Bureau measures taken to ensure future compliance with the permit conditions.
- **8.** On March 14, 2016, the Bureau received the CAV from the Respondent. The CAV was determined to be satisfactory by the Bureau on March 16, 2016.
- 9. The Parties have engaged in settlement discussions to resolve the NOV without further proceedings.

## II. COMPROMISE AND SETTLEMENT

#### A. GENERAL

- 10. The Respondent does not admit any of the allegations in the NOV. To avoid further legal proceedings, the Division and the Respondent agree to the terms and conditions in this Final Order to resolve the alleged violations in the NOV.
  - 11. The Parties admit jurisdiction and consent to the relief specified herein.

#### **B. CIVIL PENALTY**

- 12. In compromise and settlement of the alleged violations set forth in the NOV and upon consideration of the seriousness of the alleged violations and Respondent's good faith efforts to comply, the Parties agree that the Respondent shall pay a civil penalty of \$29,120.00 to the State of New Mexico within 30 calendar days after the effective date of this Final Order.
- 13. Payment shall be made to the *State of New Mexico General Fund* by certified or corporate check and sent to the following address:

If the Respondent fails to make timely and complete payment of the civil penalty, the Respondent shall pay a stipulated penalty of \$250.00 per day for each day a payment is not timely or complete. The Respondent shall not contest or dispute in any way the stipulated penalty of \$250.00 per day in the event that the Department brings an action against the Respondent for the failure to make timely or complete payment.

#### III. OTHER TERMS AND CONDITIONS

#### A. RESERVATION OF RIGHTS AND DEFENSES

15. This Final Order shall not be construed to prohibit or limit in any way the Department from requiring the Respondent to comply with any applicable state or federal requirement not resolved herein. This Final Order shall not be construed to prohibit or limit in any way the Department from seeking any relief authorized by the AQCA for violation of any state or federal requirement applicable to the Respondent not resolved herein. This Final Order shall not be construed to prohibit or limit in any way the Respondent from raising any defense to a Department action seeking such relief.

#### B. MUTUAL RELEASE

16. The Parties mutually release each other from all claims that each party raised or could have raised against the other regarding the facts and violations alleged in the NOV. Such release applies only to civil liability.

### C. WAIVER OF STATE LIABILITY

17. The Respondent shall assume all costs and liabilities incurred in performing all obligations under this Final Order. The Department, on its own behalf and on behalf of the State of New Mexico, does not assume any liability for the Respondent's performance of any obligation under this Final Order.

#### D. EFFECTIVE DATE AND TERMINATION DATES

- 18. This Final Order shall become effective on the date it has been signed by the Department Secretary.
- 19. Except as otherwise provided in this Paragraph, the terms of this Final Order shall terminate when the Respondent has fulfilled the requirements of this Final Order. The reservations of rights and defenses and the mutual release in Paragraphs 15 and 16 shall survive the execution and performance if this Final Order, and shall remain in full force and effect as an agreement between the Parties.

#### E. INTEGRATION

20. This Final Order merges all prior written and oral communications between the Parties concerning the subject matter of this Final Order, contains the entire agreement between the Parties, and shall not be modified without the express written agreement of the Parties.

#### F. BINDING EFFECT

21. This Final Order shall be binding on the Parties and their officers, directors, employees, agents, subsidiaries, successors, assigns, trustees, or receivers.

#### G. AUTHORITY OF SIGNATORIES

22. The persons executing this Final Order on behalf of the Respondent and the Division, respectively, represent that he or she has the authority to execute this Final Order on behalf of the Respondent and the Division.

#### H. SIGNATURE AND COUNTERPARTS

23. This Agreement may be executed in multiple counterparts, each of which shall be deemed an original, but all of which shall constitute one and the same agreement.
