RE: Notice of Violation – Stage 2 Disinfectants/Disinfection Byproducts Rule Monitoring

Loran Cushman:

This letter serves as Notice of Violation that Animas School System did not complete all required Stage 2 Disinfectants/Disinfection Byproducts Rule (DBP2) monitoring for the contaminants and compliance period listed in Table 1 below. The monitoring requirements for DBP2 are defined in Section 20.7.10.100 New Mexico Administrative Code (NMAC) [incorporating 40 Code of Federal Regulations (CFR) Sections 141.621, 141.625, 141.627, and 141.628].

Pursuant to Section 20.7.10.100 NMAC [incorporating 40 CFR Section 141.204(c)(1)], you are required to notify your customers of this non-sampling violation by <u>mail or other direct delivery to each customer</u> and any other methods (i.e., publication in a local newspaper or posting in conspicuous locations) as necessary to inform the public within one year from the date of this letter. Public notice must remain in place <u>no</u> <u>less than seven days</u> or as long as the violation still exists, which will be until the next round of compliance sampling is conducted. The Animas School System must repeat the notice annually for as long as the violation persists.

Pursuant to 20.7.10.100 NMAC [incorporating 40 CFR Section 141.31(d)], the Animas School System must certify that the notice was published and the method of publication, by submitting a completed copy of the enclosed Public Notification Certification Form to the DWB within 10 days of completing the public notification requirements. A representative copy of each type of notice distributed, published, posted or made available to the people served by the system must be included with the certification form.

Please fill out and return the enclosed Public Notice Certification Form to: Oneva Peña by email to <u>nmenv.dbp@env.nm.gov</u> Failure to comply with public notice requirements will result in an additional violation (failure to notify the public and the state) being issued without notice to the Animas School System. Continued failure to comply with public notification requirements, as defined in 20.7.10.100 NMAC [incorporating 40 CFR Sections 141.204(c)(1) and 141.31(d)] will result in escalated enforcement actions including issuance of Administrative Orders with possible penalties assessed against the Animas School System.

NMED-DWB reserves the right to take additional enforcement action regarding the violations identified in this NOV, to include the issuance of an Administrative Compliance Order compelling compliance and issuing civil penalties.

Pursuant to the NMED Delegation Order dated February 19, 2024, the Cabinet Secretary has delegated the authority to issue Notice of Violations to DWB Compliance Supervisor Brandi Littleton.

Please note that your facility will appear on the Department's Enforcement Watch as a result of this NOV (see: <u>https://www.env.nm.gov/enforcement-watch/</u>). Further, the Department will issue a press release to local media highlighting your public water system as appearing on this webpage. Your public water system will remain on the Enforcement Watch website as an active matter until this matter is fully resolved.

If you are required to provide Tier 3 notification, you must provide public notice to persons served within one year after you learn of the violation 20.7.10.100 NMAC [incorporating 40 CFR 141.204(b)]. Multiple monitoring violations can be serious, and the NMED DWB may have more stringent requirements. Check with the NMED DWB to make sure you meet its requirements.

Community systems must use one of the following 20.7.10.100 NMAC [incorporating 40 CFR 141.204(c)]:

- Hand or direct delivery
- Mail, as a separate notice or included with the bill

Noncommunity systems must use one of the following 20.7.10.100 NMAC [incorporating 40 CFR 141.204(c)]:

- Posting in conspicuous locations

You may need to modify the template for a notice for individual monitoring violations. This example presents violations in a table; however, you may write out an explanation for each violation if you wish. For any monitoring violation for volatile organic compounds (VOCs) or other groups, you may list the group name in the table, but you must provide the name of every chemical in the group on the notice, e.g., in a footnote.

You may need to modify the notice if you had any monitoring violations for which monitoring later showed a maximum contaminant level or other violation. In such cases, you should refer to the public notice you issued at that time. If you do modify the notice, you must still include all required PN elements from 40 CFR 141.205(a) and leave the mandatory language unchanged (see below).

Corrective Action

Monitoring Requirements Not Met for Animas School System
