Re: Notice of Violation – Failure to submit 2022 Calendar Year Consumer Confidence Report Certification

Dear Janie Edwards,

This letter serves as a Notice of Violation that the High Rolls Community Water Users Coop failed to submit the 2022 Calendar Year Consumer Confidence Report (CCR) certification to the New Mexico Environment Department Drinking Water Bureau. Pursuant to Section 20.7.10.100 NMAC [incorporating 40 Code of Federal Regulations (CFR) § 141.155(c), all community water systems must provide a Consumer Confidence Report (CCR) certification to the New Mexico Environment Department Drinking Water Bureau no later than three months from the date the CCR is to be distributed (October 1st) of each year.

The High Rolls Community Water Users Coop must provide a 2022 Calendar Year CCR certification to the Drinking Water Bureau to prevent additional violations.

NMED-DWB reserves the right to take additional enforcement action regarding the violations identified in this NOV, to include the issuance of an Administrative Compliance Order compelling compliance and issuing civil penalties.

Pursuant to the NMED Delegation Order dated March 24, 2023, the Cabinet Secretary has delegated the authority to issue Notice of Violations to DWB Bureau Chief Joe R. Martinez.

Please note that your facility will appear on the Department's Enforcement Watch as a result of this NOV (see: <https://www.env.nm.gov/enforcement-watch/>). Further, the Department will issue a press release to local media highlighting your public water system as appearing on this webpage. Your public water system will remain on the Enforcement Watch website as an active matter until this matter is fully resolved."
