Dear Messrs. White and Dodge:

The New Mexico Environment Department (NMED) has received the United States Department of Energy (DOE) and the Los Alamos National Security, L.L.C.'s (LANS) (collectively, the Permittees) *Request for a Class I Permit Modification to the Los Alamos National Laboratory (LANL) Hazardous Waste Facility Permit, Attachment K EPA ID No. NM0890010515*, dated May 2013 and referenced by LA-UR-13-22880 (Request). The Request proposed the addition of Pit 38 and Pit 39 to Attachment K of the Permit as Areas of Concern (AOCs). NMED has reviewed the Permittees' Request and hereby approves this request and deems it administratively complete with the following modifications:

**1. Pit 38**

The Pit 38 is designated as a solid waste management unit (SWMU) as outlined in NMED's January 11, 2013 letter titled *Response to Solid Waste Management Unit Assessment Report for the Pit 38 Newly Identified Area of Concern*. This letter specifically states, "[t]he Report indicates that mixed low level waste was disposed of in Pit 38 in 1996. More recent disposal of decontamination water containing hazardous constituents has also been documented by the Permittees (LA-UR-12-23557). This disposal is considered to be systematic; therefore, Pit 38 meets the definition of a Solid Waste Management Unit (SWMU) as defined in the March 1, 2005 Consent Order and the current Facility Hazardous Waste Permit. The Permittees must submit a Permit Modification Request to add Pit 38 to the list of SWMUs no later than May 10, 2013. No further investigation or remediation outside of the remedy selected through the Corrective Measures Evaluation process is required."

**2. Pit 39**

Pit 39 is also designated as a SWMU. The Permittees' March 28, 2013 *Solid Waste Management Unit Assessment Report for the Pit 39 Newly Identified Area of Concern* indicates that mixed low level waste was disposed of in Pit 39 on two separate occasions in 1997. This disposal is considered to be systematic; therefore, Pit 39 meets the definition of a SWMU as defined in the Permittees' current Facility Hazardous Waste Permit. No further investigation or remediation outside of the remedy selected through the Corrective Measures Evaluation process is required.

Pit 38 (SWMU 54-023) and Pit 39 (SWMU 54-024) has been added to Attachment K Table K-1, *SWMUs and AOCs Requiring Corrective Action*, of Attachment K, *Listing of SWMUs and AOCs*. The revised version of the relevant page of Table K-1 incorporating the modifications is attached.

The modifications identified above were put into effect as requested by the Permittees and modified by NMED under the conditions specified in 20.4.1.900 NMAC (incorporating 40 CFR §270.42(a)(1)). NMED has incorporated these Class 1 modifications into the LANL Permit.

The New Mexico Hazardous Waste Permit and Corrective Action Fee Regulations, 20.4.2.201.B(2)(b) NMAC require the assessment of fees. The fee invoice for the Class 1 Permit Modification Request, is attached to this letter.

Payment is due within sixty (60) calendar days from the date that you receive the invoices in accordance with 20.4.2.301.C NMAC. If you disagree with the fees assessed, you may notify the NMED in writing, at the address above, of the intent to appeal the invoice under the provisions of 20.4.2.302.A NMAC.

If payment is by check, then you must provide the invoice number on the check. If payment is transmitted electronically, then you must submit a letter to Mr. James Valdez, NMED Hazardous Waste Bureau, indicating the invoice number, payment amount, and the assessed activity prior to transferring funds.
