2022 Four Corners Air Quality Group Meeting Summary:

Day 1 Wednesday September 21, 2022: Climate Action and Equity / Environmental Justice Focus

- 1. The meeting was opened with a welcome from Mark Jones from NMED and Megan McCarthy representing Colorado's Air Division. Nathalie Eddy, Air Quality Liaison with the CDPHE Environmental Justice Program, gave a brief land acknowledgement to recognize the historic indigenous occupation and use of the land on which the meeting was held. Michael Baca, Control Unit Strategies Manager at NMED, Abby Fulton from EPA's Region 8 Air Program and Trisha Oeth, Environmental Director at CDPHE gave a more extensive opening welcome.

- 2. The presentations began with a review on the different state's Climate and Air Quality Regulatory Landscapes by Jojo La, Policy Advisor with CDPHE, Claudia Borchert, Climate Change Coordinator with NMED and Becky Close, Air Quality Policy Section Manager, with UDEQ.

- 3. After discussing broader perspectives of state policy, the group dove into a more focused series of discussions honing in on the Four Corners Region for the remainder of the day. This started with an overview of the region's complex geography and cultural heritage through presentations given by the UMUT, SUIT, NNEPA, NPS and BLM. These presentations helped orient the audience to the area and gain a better understanding of the different agencies and organizations that represent the region.

After a lunch break, the group reconvened with a panel discussion on Climate Equity and Environmental Justice, which included hearing from representatives from Diné C.A.R.E., NAEVA, the Sustainable Economic Task Force, the Colorado League of Conservation Voters, the Colorado Climate Equity Community Advisory Committee as well as from the two state's Environmental Justice and Climate Programs.

- 6. After the panel, Anita Rose, Regional Air Program Manager and Climate Change Coordinator with the USFS gave an informative presentation highlighting climate change impacts and USFS land management strategies in the region.

The final presentations of the day were focused on hearing specifically from the tribes present in the region on how the specific tribe is experiencing climate change, specific impacts seen and potential solutions for managing those impacts. Janice Archuleta from the UMUT and Keith Howard from the NNFWD joined us to present.

Day 2 Thursday, September 22, 2022: Monitoring Trends, Criteria Pollutants, Regional Haze Plans

- 1. The second day of the meeting began by jumping right into the day's welcome with Michael Baca from NMED. In his welcome, Michael drew upon the distinct connections between the climate change and environmental justice issues discussed in Day 1, and the more traditional, criteria pollutant and monitoring-based topics on the Day 2 agenda.
- 2. After the welcome, the group started with a series of presentations and discussion on the Four Corners Air Monitoring Trends and a Q&A at the end for the panel on Ozone standard implementations and National Ambient Air Quality Standards (NAAQS) reviews by EPA. The presenters included Mark Jones, NMED; Suzy Apodaca, EPA R6; Abby Fulton, EPA R8; Will Vicars, CDPHE; Lisa Devore, NPS; and Arlyssia Sells, UMUT.
