

Legal Notice
and
Preliminary Determination for an Air Quality Permit for
Harvest Four Corners LLC

Harvest Four Corners LLC at 1755 Arroyo Dr, Bloomfield, NM has submitted an air quality permit application to the Air Quality Bureau (AQB), New Mexico Environment Department (NMED) for an air quality permit to modify 32-9 Central Delivery Point. The application file has been assigned Permit No. 0924M4 and TEMPO Agency Interest No. 1226. The exact location of the facility is at latitude and longitude decimal degrees: 36.8953, -107.8611 Datum: WGS84. To aid in locating this facility, the approximate location is ~9 miles NE of Aztec in San Juan County, NM.

The main purpose of the facility is to compress and dehydrate natural gas for transport through natural gas pipelines. The proposed modification will consist of adding catalytic converters to four (4) of the existing Waukesha 7042GL 4SLB engines (Units 1-4) to comply with the ozone rule emission limits; an engine-like replacement of existing Waukesha 7042GL 4SLB engine (Unit 5); and addition of one (1) Waukesha 7044GSI 4SRB engine (Unit 6). Both units 5 and 6 will be equipped with a catalytic converter. There are six (6) reciprocating compressors associated with the engines (Units RC1-RC6); addition of two (2) 10 MMSCFD dehydrators (Units 11 and 13); modification of startup, shutdown, and maintenance emissions (Unit SSM) to include both engine and dehydrator blowdown events; removal of malfunction emissions (Unit M1); identification of the pneumatic controllers (Units PC1-PC37); and addition of five (5) pneumatic pumps (Units PP1-PP5).

Total air pollutant emissions to the atmosphere are estimated to be approximately as follows. Parentheses note changes in emissions from previous operating permit – P030-R5. Emissions are expressed in tons per year (tpy). Nitrogen Oxides (NO_x) at 96.0 tons per year (tpy) (-4.4); Carbon Monoxide (CO) at 50.6 tpy (-126.2); Volatile Organic Compounds (VOC) at 102.0 tpy (+10.9); Particulate Matter 10 microns or less (PM₁₀) at 4.0 tpy (+1.7); and Particulate Matter 2.5 microns or less (PM_{2.5}) at 4.0 tpy (+1.7); and greenhouse gas (CO₂e) < 75,000 tpy. These emission estimates could change slightly during the course of the Department's review of the application.

The NMED has conducted a preliminary review of the information submitted with the permit application. The preliminary review and applicant's analysis of ambient air quality impacts indicates that the facility's air emissions will meet the air quality standards for NO_x, CO, VOC, PM₁₀, and PM_{2.5}. VOCs are a pre-cursor to ozone and the NMED does not require an individual ozone ambient impact analysis for each application. To determine compliance with national ambient air quality standards for ozone, NMED uses air monitors to monitor ozone concentrations. A full review will evaluate the estimated emission rates for the pollutants listed in this public notice and determine compliance with ambient air quality requirements and standards.

Based on the applicant's analysis, a preliminary determination is that this facility will comply with the requirements of Title 20, New Mexico Administrative Code (NMAC), Chapter 2, Parts 1, 7, 50, 61, 72, 73, 75, 77 and 82; 40 CFR 60 Subparts A, JJJJ, OOOOa, and OOOOb; 40 CFR 63 Subparts A, HH, and ZZZZ; and the New Mexico Air Quality Control Act. Therefore, the preliminary intent of NMED is to issue the air quality permit on or before March 8th, 2026. This source is a PSD minor source according to 20.2.74 NMAC.

To ensure compliance with state and federal air regulations, the permit is expected to include conditions that limit the emissions, hours of operation, production rate, and conditions that will require record keeping and reporting to the Department.

The permit application is available for review on the AQB Public Notices of Permitting Actions website www.env.nm.gov/public-notices.

All interested persons have thirty (30) days from the date this notice is published, to notify the Department in writing of their interest in the permit application. The written comments should refer to the company name, facility name and Permit No. (or send a copy of this notice along with your comments). The written comments shall state the nature of the issues raised and how it relates to the requirements of applicable state and federal air quality regulations and the Clean Air Act. The Department will notify all persons, who have provided written comments as to when and where the Department's analysis may be reviewed. Although all written comments will be made part of the public record, any person who does not express interest in writing before the end of this first thirty (30) day period will not receive such notification.

If the Department receives written public comment before the end of the Department's thirty (30) day public notice, the Department's analysis will be made available for review for thirty (30) days at the NMED district or field office nearest to the source before the permit will be issued. Written comments on the analysis or permit application may be submitted to the Department during this second thirty (30) day period or at any time before the permit is issued or denied.
